Description An add-on package to 'DImodels' for the fitting of biodiversity and ecosystem function relationship study data with multiple ecosystem function responses and/or time points. This package uses the multivariate and repeated measures Diversity-Interactions (DI) methods developed by Kirwan et al. (2009) <[doi:10.1890/08-1684.1](https://doi.org/10.1890/08-1684.1)>, Finn et al. (2013) <[doi:10.1111/1365-2664.12041](https://doi.org/10.1111/1365-2664.12041)>, and Dooley et al. (2015) <[doi:10.1111/ele.12504](https://doi.org/10.1111/ele.12504)>.

There are two recommended functional groupings: grouping grasses (G1, G2) and legumes (L1, L2), or grouping fast-establishing species (G1, L1) and temporally persistent species (G2, L2).

Three ecosystem functions were recorded by summing recordings from multiple harvests over the years of the experiment: (1) aboveground biomass of sown species (Sown) (t DM ha⁻¹), (2) aboveground biomass of weed species (Weed) (t DM ha⁻¹) and (3) the total annual yield of nitrogen in harvested aboveground biomass (N) (t DM ha⁻¹). It is recommended to perform a linear transformation on the response value 'Y' before commencing a multivariate analysis of this dataset.

This dataset was used to create the datasets 'Belgium_MV' and 'Belgium_RM'.

Three ecosystem functions were recorded by summing recordings from multiple harvests over the years of the experiment: (1) aboveground biomass of sown species (Sown) (t DM ha⁻¹), (2) aboveground biomass of weed species (Weed) (t DM ha⁻¹) and (3) the total annual yield of nitrogen in harvested aboveground biomass (N) (t DM ha⁻¹). A linear transformation on the response was applied to the value 'Y', where they now represent a percentage of the top 10% of recorded values for each function, i.e., each response was multiplied by 100, then divided by the mean of the top three readings.

One ecosystem function (aboveground biomass (t DM ha⁻¹)) was recorded by summing recordings from four harvests over each year, for three years. The treatment applied varied the quantity of nitrogen applied (core plots with a quantity of 0 units while treated plots had 180 units applied).

Multivariate Diversity-Interactions (DI) Models with Repeated Measures

Description

This package is an add-on to the **'DImodels'** package (Moral *et al.*, 2023). It enables the fitting of Diversity-Interactions (DI) models for (1) univariate repeated measures responses (Finn *et al.*, 2013), (2) multivariate responses at a single point in time (Dooley *et al.*, 2015), or (3) multivariate repeated measures responses. These responses will come from a biodiversity and ecosystem function (BEF) relationship study which aims to test the relationship between ecosystem functioning and ecosystem design, including species identities, interactions, and additional factors such as treatments and time. This data can be used to construct a regression model through the main function of this package [DImulti](#).

Details

Data

This package is intended for use with data containing multiple ecosystem function responses and/or time points from a biodiversity and ecosystem function (BEF) relationship study. The dataset should

contain a column for each species' proportion, so that each row of these columns sum to one. Each row of the data should also contain an identifier for the experimental unit being referenced, these identifiers must be unique to each experimental unit, but remain consistent over time and across functions. For each experimental unit included there must be recordings of either:

- a single community level ecosystem function response variable taken at multiple time points (repeated measures),
- multiple community level ecosystem function responses (multivariate), or
- multiple community level ecosystem function responses taken at multiple time points (multivariate repeated measures).

Ecosystem functions may be stored in a long or wide format while repeated measures must be stored in a long format.

Additionally, by calling the function `DImultiApp()`, you can interact with the provided R Shiny app, which aids in fitting and visualising multivariate or repeated measures models through a user-friendly interface.

Introduction to multivariate & repeated measures Diversity-Interactions models

Diversity-Interactions (DI) models are a regression based approach to modelling the biodiversity ecosystem function (BEF) relationship which assumes that the main driver behind changes in ecosystem functioning is the initial relative abundance (or proportions) of the species present. These models can be estimated using least squares estimation methods.

An example of a univariate DI model can be seen below,

$$y = \sum_{i=1}^S \beta_i p_i + \sum_{\substack{i,j=1 \\ i < j}}^S \delta_{ij} (p_i p_j)^\theta + \alpha A + \epsilon$$

where the response y represents the recorded ecosystem function, p_i represents the initial proportion of the i^{th} species, therefore the p values sum to 1 and form a simplex space, and scales the ID effect of the species, β_i ; if no species interactions or treatments are required in the model, the response y is the weighted average of the species identity effects. S represents the number of unique species present in the study. Similarly to the ID effect, the interaction effect, δ , between species is scaled by some combination of the products of species proportions, which depends on the interaction structure chosen. The example above shows the full pairwise structure, which has a unique interaction term, δ_{ij} , per pair of species i & j . The nonlinear term θ (Connolly *et al.*, 2013; Vishwakarma *et al.*, 2023) is included in the model to allow the shape of the BEF relationship to change. This parameter can be estimated using profile log-likelihood optimisation (Brent, 1973) or can be assigned a set value based on an *a priori* assumption/knowledge. A may include blocks or treatment terms, and α is a vector of the corresponding effect coefficients.

For further details of univariate DI modelling, see `?DImodels`, Kirwan *et al.*, 2009, and Moral *et al.*, 2023.

The multivariate DI model (Dooley *et al.*, 2015) extends the DI modelling framework to allow for the estimation of multiple ecosystem functions simultaneously, accounting for any existing covariance between functions through the error term. These models can be further extended through the introduction of repeated measures over multiple time points.

The structure for such models is:

$$y_{kmt} = \sum_{i=1}^S \beta_{ikt} p_{im} + \sum_{\substack{i,j=1 \\ i < j}}^S \delta_{ijkt} (p_{im} p_{jm})^{\theta_k} + \alpha_{kt} A + \epsilon_{kmt}$$

where y_{kmt} refers to the value of the k^{th} ecosystem function from the m^{th} experimental unit at a time point t . For an experimental unit m , β_{ikt} scaled by p_{im} is the expected contribution of the i^{th} species to the k^{th} response at time point t and is referred to as the i^{th} species' ID effect. The value of the nonlinear parameter θ is allowed to vary between ecosystem functions, in turn allowing the fixed effect structure to change across functions, in recognition that the nature of the species interactions could change between ecosystem functions.

In the case that a dataset contains only a single ecosystem function, the corresponding subscript k can simply be removed from the equation, the same can be said for the removal of the subscript t in the instance that a dataset contains a single time point.

The structure of the error term

For a univariate DI model, the error term is assumed to follow a normal distribution with mean 0 and variance σ^2 .

$$\epsilon \sim N(0, \sigma^2)$$

When the model is extended to fit multivariate ($k > 1$) and/or repeated measures ($t > 1$) data, the error term is now assumed to follow a multivariate normal distribution with mean 0 and variance Σ^* .

$$\epsilon \sim MVN(0, \Sigma^*)$$

Σ^* is a block diagonal matrix, with one $kt \times kt$ block, Σ , for each experimental unit m . We refer to Σ as the variance covariance matrix for our ecosystem functions and time points. Typically, it includes a unique variance per combination of ecosystem functions and time points along the diagonal and a unique covariance between each pair of combinations on the off-diagonal. Autocorrelation structures may be implemented on the matrix Σ , either to simplify the estimation process or based on *a priori* knowledge. One structure is chosen for the ecosystem functions and another for repeated measures/time points, the two matrices are then estimated independently and combined using the Kronecker product (\otimes), a matrix multiplication method. In the case that the data is only multivariate ($k > 1$ & $t = 1$) or only has repeated measures ($k = 1$ & $t > 1$), only one autocorrelation structure needs to be chosen, with no multiplication necessary.

Three such structures are currently available in this package for repeated measures responses, and two are available for multivariate responses:

1. **UN**: When each element of Σ is set to estimate independently, it is said to be unstructured or follow the general structure and is the preferred option in the case that there is no a priori information on the nature of these relationships. [corSymm](#)
2. **CS**: A simpler structure is compound symmetry, where it is assumed that each ecosystem function or time point has the same variance value σ^2 and each pair has the same covariance

value $\sigma^2\rho$. This structure is not preferred for use with multiple ecosystem functions as it provides no meaningful interpretation, however it is allowed in this package if the model requires simplification. [corCompSymm](#)

3. **AR(1)**: An autocorrelation structure exclusive to repeated measures data is an autoregressive model of order one, which assumes that, each time point has the same variance, σ^2 , and as the distance in pairs of time points increases, the covariance between them changes by a factor of ρ . [corAR1](#)

Details

Data

This package is intended for use with data containing multiple ecosystem function responses and/or time points from a biodiversity and ecosystem function (BEF) relationship study. The dataset should contain a column for each species' proportion, so that each row of these columns sum to one. Each row of the data should also contain an identifier for the experimental unit being referenced, these identifiers must be unique to each experimental unit, but remain consistent over time and across functions. For each experimental unit included there must be recordings of either:

- a single community level ecosystem function response variable taken at multiple time points (repeated measures),
- multiple community level ecosystem function responses (multivariate), or
- multiple community level ecosystem function responses taken at multiple time points (multivariate repeated measures).

Ecosystem functions may be stored in a long or wide format while repeated measures must be stored in a long format.

Additionally, by calling the function `DImultiApp()`, you can interact with the provided R Shiny app, which aids in fitting and visualising multivariate or repeated measures models through a user-friendly interface.

Introduction to multivariate & repeated measures Diversity-Interactions models

Diversity-Interactions (DI) models are a regression based approach to modelling the biodiversity ecosystem function (BEF) relationship which assumes that the main driver behind changes in ecosystem functioning is the initial relative abundance (or proportions) of the species present. These models can be estimated using least squares estimation methods.

An example of a univariate DI model can be seen below,

$$y = \sum_{i=1}^S \beta_i p_i + \sum_{\substack{i,j=1 \\ i < j}}^S \delta_{ij} (p_i p_j)^\theta + \alpha A + \epsilon$$

where the response y represents the recorded ecosystem function, p_i represents the initial proportion of the i^{th} species, therefore the p values sum to 1 and form a simplex space, and scales the ID effect of the species, β_i ; if no species interactions or treatments are required in the model, the response y is the weighted average of the species identity effects. S represents the number of unique species present in the study. Similarly to the ID effect, the interaction effect, δ , between species is scaled by some combination of the products of species proportions, which depends on the interaction structure chosen. The example above shows the full pairwise structure, which has a unique interaction term, δ_{ij} , per pair of species i & j . The nonlinear term θ (Connolly *et al.*, 2013; Vishwakarma *et al.*, 2023) is included in the model to allow the shape of the BEF relationship to change. This parameter can be estimated using profile log-likelihood optimisation (Brent, 1973) or can be assigned a set value based on an *a priori* assumption/knowledge. A may include blocks or treatment terms, and α is a vector of the corresponding effect coefficients.

For further details of univariate DI modelling, see ?DImodels, Kirwan *et al.*, 2009, and Moral *et al.*, 2023.

The multivariate DI model (Dooley *et al.*, 2015) extends the DI modelling framework to allow for the estimation of multiple ecosystem functions simultaneously, accounting for any existing covariance between functions through the error term. These models can be further extended through the introduction of repeated measures over multiple time points.

The structure for such models is:

$$y_{kmt} = \sum_{i=1}^S \beta_{ikt} p_{im} + \sum_{\substack{i,j=1 \\ i < j}}^S \delta_{ijkt} (p_{im} p_{jm})^{\theta_k} + \alpha_{kt} A + \epsilon_{kmt}$$

where y_{kmt} refers to the value of the k^{th} ecosystem function from the m^{th} experimental unit at a time point t . For an experimental unit m , β_{ikt} scaled by p_{im} is the expected contribution of the i^{th} species to the k^{th} response at time point t and is referred to as the i^{th} species' ID effect. The value of the nonlinear parameter θ is allowed to vary between ecosystem functions, in turn allowing the fixed effect structure to change across functions, in recognition that the nature of the species interactions could change between ecosystem functions.

In the case that a dataset contains only a single ecosystem function, the corresponding subscript k can simply be removed from the equation, the same can be said for the removal of the subscript t in the instance that a dataset contains a single time point.

The structure of the error term

For a univariate DI model, the error term is assumed to follow a normal distribution with mean 0 and variance σ^2 .

$$\epsilon \sim N(0, \sigma^2)$$

When the model is extended to fit multivariate ($k > 1$) and/or repeated measures ($t > 1$) data, the error term is now assumed to follow a multivariate normal distribution with mean 0 and variance Σ^* .

$$\epsilon \sim MVN(0, \Sigma^*)$$

Σ^* is a block diagonal matrix, with one $kt \times kt$ block, Σ , for each experimental unit m . We refer to Σ as the variance covariance matrix for our ecosystem functions and time points. Typically, it includes a unique variance per combination of ecosystem functions and time points along the diagonal and a unique covariance between each pair of combinations on the off-diagonal. Autocorrelation structures may be implemented on the matrix Σ , either to simplify the estimation process or based on *a priori* knowledge. One structure is chosen for the ecosystem functions and another for repeated measures/time points, the two matrices are then estimated independently and combined using the Kronecker product (\otimes), a matrix multiplication method. In the case that the data is only multivariate ($k > 1$ & $t = 1$) or only has repeated measures ($k = 1$ & $t > 1$), only one autocorrelation structure needs to be chosen, with no multiplication necessary.

Three such structures are currently available in this package for repeated measures responses, and two are available for multivariate responses:

1. **UN**: When each element of Σ is set to estimate independently, it is said to be unstructured or follow the general structure and is the preferred option in the case that there is no a priori information on the nature of these relationships. [corSymm](#)
2. **CS**: A simpler structure is compound symmetry, where it is assumed that each ecosystem function or time point has the same variance value σ^2 and each pair has the same covariance value $\sigma^2\rho$. This structure is not preferred for use with multiple ecosystem functions as it provides no meaningful interpretation, however it is allowed in this package if the model requires simplification. [corCompSymm](#)
3. **AR(1)**: An autocorrelation structure exclusive to repeated measures data is an autoregressive model of order one, which assumes that, each time point has the same variance, σ^2 , and as the distance in pairs of time points increases, the covariance between them changes by a factor of ρ . [corAR1](#)

The appearance of the printed information will differ depending on whether a user has installed some combination of the suggested packages "crayon", "cli", and "fansi". These changes are mainly cosmetic, with crayon making the output easier to read, cli providing links to help files, and fansi enabling the reading of special characters in R markdown (Rmd) files. See 'Examples' below for suggested code to include in Rmd files.

Description

The simMV dataset was simulated from a multivariate DI model. It contains 192 plots comprising of six species that vary in proportions (p1 - p6). Each plot was replicated once for testing a two-level factor treat, included at levels 0 and 1, resulting in a total of 384 plots. There are four simulated responses (Y1 - Y4) recorded in a wide data format (one column per response). The data was simulated assuming that there were existing covariances between the responses, an additive treatment effect, and both species identity and species interaction effects were present.

Further information on Diversity-Interactions models is also available in Kirwan *et al* 2009 and Connolly *et al* 2013. The multivariate DI model was developed by Dooley *et al.*, 2015.

Parameter values for the simulation

Multivariate DI models take the general form of:

$$y_{km} = Identities_{km} + Interactions_{km} + Structures_k + \epsilon_{km}$$

where y are the community-level responses, the *Identities* are the effects of species identities for each response and enter the model as individual species proportions at the beginning of the time period, the *Interactions* are the interactions among the species proportions, while *Structures* include other experimental structures such as blocks, treatments or density.

 - Y1 = 3.5
 - Y2 = -0.3
 - Y3 = 5.5
 - Y4 = -1.0
- ϵ assumed to have a multivariate normal distribution with mean 0 and Sigma:

Further information on Diversity-Interactions models is also available in Kirwan *et al.*, 2009 and Connolly *et al.*, 2013.

Parameter values for the simulation

Repeated measures DI models take the general form of:

$$y_{mt} = Identities_{mt} + Interactions_{mt} + Structures_t + \epsilon_{mt}$$

where y are the community-level responses, the *Identities* are the effects of species identities for each response and enter the model as individual species proportions measured at the beginning of the time period, the *Interactions* are the interactions among the species proportions, while *Structures* include other experimental structures such as blocks, treatments, or density.

The dataset simRM was simulated with:

- identity effects for the four species for each time:
 - time1 = 4.1, 2.1, 3.6, 4.8
 - time2 = 2.3, 2.4, 5.1, 5.0
 - time3 = 0.7, 2.3, 6.5, 5.9
- additive interaction effects for each time:
 - time1 = 3.3, 4.0, 1.3, 5.2
 - time2 = 3.6, 4.5, 0.5, 6.5
 - time3 = 4.5, 5.2, 0.6, 7.8
- ϵ assumed to have a multivariate normal distribution with mean 0 and Sigma:
