hugene20stprobesetACCNUM

*Map Manufacturer identifiers to Accession Numbers*

---

## Description

hugene20stprobesetACCNUM is an R object that contains mappings between a manufacturer's identifiers and manufacturers accessions.

## Details

For chip packages such as this, the ACCNUM mapping comes directly from the manufacturer. This is different from other mappings which are mapped onto the probes via an Entrez Gene identifier.

Each manufacturer identifier maps to a vector containing a GenBank accession number.

hugene20stprobesetALIAS2PROBE

*Map between Common Gene Symbol Identifiers and Manufacturer Identifiers*

---

### Description

hugene20stprobesetALIAS is an R object that provides mappings between common gene symbol identifiers and manufacturer identifiers.

### Details

Each gene symbol is mapped to a named vector of manufacturer identifiers. The name represents the gene symbol and the vector contains all manufacturer identifiers that are found for that symbol. An NA is reported for any gene symbol that cannot be mapped to any manufacturer identifiers.

This mapping includes ALL gene symbols including those which are already listed in the SYMBOL map. The SYMBOL map is meant to only list official gene symbols, while the ALIAS maps are meant to store all used symbols.

---

### Description

Welcome to the hugene20stprobeset.db annotation Package. The purpose of this package is to provide detailed information about the hugene20stprobeset platform. This package is updated biannually.

You can learn what objects this package supports with the following command:

hugene20stprobesetCHR *Map Manufacturer IDs to Chromosomes*

---

## Description

hugene20stprobesetCHR is an R object that provides mappings between a manufacturer identifier and the chromosome that contains the gene of interest.

## Details

Each manufacturer identifier maps to a vector of chromosomes. Due to inconsistencies that may exist at the time the object was built, the vector may contain more than one chromosome (e.g., the identifier may map to more than one chromosome). If the chromosomal location is unknown, the vector will contain an NA.

Mappings were based on data provided by: Entrez Gene <ftp://ftp.ncbi.nlm.nih.gov/gene/DATA> With a date stamp from the source of: 2013-Mar5

hugene20stprobesetCHRENGTHS

*A named vector for the length of each of the chromosomes*

---

## Description

hugene20stprobesetCHRENGTHS provides the length measured in base pairs for each of the chromosomes.

**Details**

This is a named vector with chromosome numbers as the names and the corresponding lengths for chromosomes as the values.

Total lengths of chromosomes were derived by calculating the number of base pairs on the sequence string for each chromosome.

hugene20stprobesetCHRLOC

*Map Manufacturer IDs to Chromosomal Location*

---

**Description**

hugene20stprobesetCHRLOC is an R object that maps manufacturer identifiers to the starting position of the gene. The position of a gene is measured as the number of base pairs.

The CHRLOCEND mapping is the same as the CHRLOC mapping except that it specifies the ending base of a gene instead of the start.

**Details**

Each manufacturer identifier maps to a named vector of chromosomal locations, where the name indicates the chromosome. Due to inconsistencies that may exist at the time the object was built, these vectors may contain more than one chromosome and/or location. If the chromosomal location is unknown, the vector will contain an NA.

Chromosomal locations on both the sense and antisense strands are measured as the number of base pairs from the p (5' end of the sense strand) to q (3' end of the sense strand) arms. Chromosomal locations on the antisense strand have a leading "-" sign (e. g. -1234567).

Since some genes have multiple start sites, this field can map to multiple locations.

*Map Ensembl gene accession numbers with Entrez Gene identifiers*

---

## Description

hugene20stprobesetENSEMBL is an R object that contains mappings between manufacturer identifiers and Ensembl gene accession numbers.

## Details

This object is a simple mapping of manufacturer identifiers to Ensembl gene Accession Numbers.

Mappings were based on data provided by BOTH of these sources: <http://www.ensembl.org/biomart/martview/> <ftp://ftp.ncbi.nlm.nih.gov/gene/DATA>

For most species, this mapping is a combination of manufacturer to ensembl IDs from BOTH NCBI and ensembl. Users who wish to only use mappings from NCBI are encouraged to see the ncbi2ensembl table in the appropriate organism package. Users who wish to only use mappings from ensembl are encouraged to see the ensembl2ncbi table which is also found in the appropriate organism packages. These mappings are based upon the ensembl table which is contains data from BOTH of these sources in an effort to maximize the chances that you will find a match.

For worms and flies however, this mapping is based only on sources from ensembl, as these organisms do not have ensembl to entrez gene mapping data at NCBI.

hugene20stprobesetENTREZID

*Map between Manufacturer Identifiers and Entrez Gene*

---

### Description

hugene20stprobesetENTREZID is an R object that provides mappings between manufacturer identifiers and Entrez Gene identifiers.

### Details

Each manufacturer identifier is mapped to a vector of Entrez Gene identifiers. An NA is assigned to those manufacturer identifiers that can not be mapped to an Entrez Gene identifier at this time.

If a given manufacturer identifier can be mapped to different Entrez Gene identifiers from various sources, we attempt to select the common identifiers. If a consensus cannot be determined, we select the smallest identifier.

hugene20stprobesetENZYME

*Maps between Manufacturer IDs and Enzyme Commission (EC) Numbers*

---

### Description

hugene20stprobesetENZYME is an R object that provides mappings between manufacturer identifiers and EC numbers. hugene20stprobesetENZYME2PROBE is an R object that maps Enzyme Commission (EC) numbers to manufacturer identifiers.

## Details

When the hugene20stprobesetENZYME mapping is viewed as a list, each manufacturer identifier maps to a named vector containing the EC number that corresponds to the enzyme produced by that gene. The names correspond to the manufacturer identifiers. If this information is unknown, the vector will contain an NA.

For the hugene20stprobesetENZYME2PROBE, each EC number maps to a named vector containing all of the manufacturer identifiers that correspond to the gene that produces that enzyme. The name of the vector corresponds to the EC number.

Enzyme Commission numbers are assigned by the Nomenclature Committee of the International Union of Biochemistry and Molecular Biology <http://www.chem.qmw.ac.uk/iubmb/enzyme/> to allow enzymes to be identified.

An Enzyme Commission number is of the format EC x.y.z.w, where x, y, z, and w are numeric numbers. In hugene20stprobesetENZYME2PROBE, EC is dropped from the Enzyme Commission numbers.

Enzyme Commission numbers have corresponding names that describe the functions of enzymes in such a way that EC x is a more general description than EC x.y that in turn is a more general description than EC x.y.z. The top level EC numbers and names are listed below:

EC 1 oxidoreductases

EC 2 transferases

EC 3 hydrolases

EC 4 lyases

EC 5 isomerases

EC 6 ligases

hugene20stprobesetGENENAME

*Map between Manufacturer IDs and Genes*

---

### Description

hugene20stprobesetGENENAME is an R object that maps manufacturer identifiers to the corresponding gene name.

### Details

Each manufacturer identifier maps to a named vector containing the gene name. The vector name corresponds to the manufacturer identifier. If the gene name is unknown, the vector will contain an NA.

Gene names currently include both the official (validated by a nomenclature committee) and preferred names (interim selected for display) for genes. Efforts are being made to differentiate the two by adding a name to the vector.

---

hugene20stprobesetGO *Maps between manufacturer IDs and Gene Ontology (GO) IDs*

---

### Description

hugene20stprobesetGO is an R object that provides mappings between manufacturer identifiers and the GO identifiers that they are directly associated with. This mapping and its reverse mapping (hugene20stprobesetGO2PROBE) do NOT associate the child terms from the GO ontology with the gene. Only the directly evidenced terms are represented here.

hugene20stprobesetGO2ALLPROBES is an R object that provides mappings between a given GO identifier and all of the manufacturer identifiers annotated at that GO term OR TO ONE OF IT'S CHILD NODES in the GO ontology. Thus, this mapping is much larger and more inclusive than hugene20stprobesetGO2PROBE.

### Details

If hugene20stprobesetGO is cast as a list, each manufacturer identifier is mapped to a list of lists. The names on the outer list are GO identifiers. Each inner list consists of three named elements: GOID, Ontology, and Evidence.

The GOID element matches the GO identifier named in the outer list and is included for convenience when processing the data using 'lapply'.

The Ontology element indicates which of the three Gene Ontology categories this identifier belongs to. The categories are biological process (BP), cellular component (CC), and molecular function (MF).

The Evidence element contains a code indicating what kind of evidence supports the association of the GO identifier to the manufacturer id. The evidence codes in use include:

IMP: inferred from mutant phenotype

IGI: inferred from genetic interaction

IPI: inferred from physical interaction

ISS: inferred from sequence similarity

IDA: inferred from direct assay

IEP: inferred from expression pattern

IEA: inferred from electronic annotation

TAS: traceable author statement

NAS: non-traceable author statement

ND: no biological data available

IC: inferred by curator

If hugene20stprobesetGO2ALLPROBES or hugene20stprobesetGO2PROBE is cast as a list, each GO term maps to a named vector of manufacturer identifiers and evidence codes. A GO identifier may be mapped to the same manufacturer identifier more than once but the evidence code can be different. Mappings between Gene Ontology identifiers and Gene Ontology terms and other information are available in a separate data package named GO.

Whenever any of these mappings are cast as a data.frame, all the results will be output in an appropriate tabular form.

Mappings between manufacturer identifiers and GO information were obtained through their mappings to manufacturer identifiers. NAs are assigned to manufacturer identifiers that can not be mapped to any Gene Ontology information. Mappings between Gene Ontology identifiers and Gene Ontology terms and other information are available in a separate data package named GO.

hugene20stprobesetMAP *Map between Manufacturer Identifiers and cytogenetic maps/bands*

---

## Description

hugene20stprobesetMAP is an R object that provides mappings between manufacturer identifiers and cytoband locations.

## Details

Each manufacturer identifier is mapped to a vector of cytoband locations. The vector length may be one or longer, if there are multiple reported chromosomal locations for a given gene. An NA is reported for any manufacturer identifiers that cannot be mapped to a cytoband at this time.

Cytogenetic bands for most higher organisms are labeled p1, p2, p3, q1, q2, q3 (p and q are the p and q arms), etc., counting from the centromere out toward the telomeres. At higher resolutions, sub-bands can be seen within the bands. The sub-bands are also numbered from the centromere out toward the telomere. Thus, a label of 7q31.2 indicates that the band is on chromosome 7, q arm, band 3, sub-band 1, and sub-sub-band 2.

*Number of mapped keys for the maps in package  
hugene20stprobeset.db*

---

### Description

hugene20stprobesetMAPCOUNTS provides the "map count" (i.e. the count of mapped keys) for each map in package hugene20stprobeset.db.

### Details

This "map count" information is precalculated and stored in the package annotation DB. This allows some quality control and is used by the [checkMAPCOUNTS](#) function defined in AnnotationDbi to compare and validate different methods (like `count.mappedkeys(x)` or `sum(!is.na(as.list(x)))`) for getting the "map count" of a given map.

hugene20stprobesetOMIM

*Map between Manufacturer Identifiers and Mendelian Inheritance in  
Man (MIM) identifiers*

---

### Description

hugene20stprobesetOMIM is an R object that provides mappings between manufacturer identifiers and OMIM identifiers.

## Details

Each manufacturer identifier is mapped to a vector of OMIM identifiers. The vector length may be one or longer, depending on how many OMIM identifiers the manufacturer identifier maps to. An NA is reported for any manufacturer identifier that cannot be mapped to an OMIM identifier at this time.

OMIM is based upon the book Mendelian Inheritance in Man (V. A. McKusick) and focuses primarily on inherited or heritable genetic diseases. It contains textual information, pictures, and reference information that can be searched using various terms, among which the MIM number is one.

hugene20stprobesetORGANISM

*The Organism information for hugene20stprobeset*

---

## Description

hugene20stprobesetORGANISM is an R object that contains a single item: a character string that names the organism for which hugene20stprobeset was built. hugene20stprobesetORGPKG is an R object that contains a character vector with the name of the organism package that a chip package depends on for its gene-centric annotation.

## Details

Although the package name is suggestive of the organism for which it was built, hugene20stprobesetORGANISM provides a simple way to programmatically extract the organism name. hugene20stprobesetORGPKG provides a simple way to programmatically extract the name of the parent organism package. The parent organism package is a strict dependency for chip packages as this is where the gene centric

information is ultimately extracted from. The full package name will always be this string plus the extension ".db". But most programatic acces will not require this extension, so its more convenient to leave it out.

### Description

KEGG (Kyoto Encyclopedia of Genes and Genomes) maintains pathway data for various organisms.

hugene20stprobesetPATH maps probe identifiers to the identifiers used by KEGG for pathways in which the genes represented by the probe identifiers are involved

hugene20stprobesetPATH2PROBE is an R object that provides mappings between KEGG identifiers and manufacturer identifiers.

### Details

Each KEGG pathway has a name and identifier. Pathway name for a given pathway identifier can be obtained using the KEGG data package that can either be built using AnnBuilder or downloaded from Bioconductor <http://www.bioconductor.org>.

Graphic presentations of pathways are searchable at url <http://www.genome.ad.jp/kegg/pathway.html> by using pathway identifiers as keys.

## Description

hugene20stprobesetPFAM is an R object that provides mappings between a manufacturer identifier and the associated Pfam identifiers.

## Details

Each manufacturer identifier maps to a named vector of Pfam identifiers. The name for each Pfam identifier is the IPI accession number where this Pfam identifier is found.

If the Pfam is a named NA, it means that the associated Entrez Gene id of this manufacturer identifier is found in an IPI entry of the IPI database, but there is no Pfam identifier in the entry.

If the Pfam is a non-named NA, it means that the associated Entrez Gene id of this manufacturer identifier is not found in any IPI entry of the IPI database.

## Description

hugene20stprobesetPMID is an R object that provides mappings between manufacturer identifiers and PubMed identifiers. hugene20stprobesetPMID2PROBE is an R object that provides mappings between PubMed identifiers and manufacturer identifiers.

## Details

When hugene20stprobesetPMID is viewed as a list each manufacturer identifier is mapped to a named vector of PubMed identifiers. The name associated with each vector corresponds to the manufacturer identifier. The length of the vector may be one or greater, depending on how many PubMed identifiers a given manufacturer identifier is mapped to. An NA is reported for any manufacturer identifier that cannot be mapped to a PubMed identifier.

When hugene20stprobesetPMID2PROBE is viewed as a list each PubMed identifier is mapped to a named vector of manufacturer identifiers. The name represents the PubMed identifier and the vector contains all manufacturer identifiers that are represented by that PubMed identifier. The length of the vector may be one or longer, depending on how many manufacturer identifiers are mapped to a given PubMed identifier.

Titles, abstracts, and possibly full texts of articles can be obtained from PubMed by providing a valid PubMed identifier. The pubmed function of annotate can also be used for the same purpose.

## Description

hugene20stprobesetPROSITE is an R object that provides mappings between a manufacturer identifier and the associated PROSITE identifiers.

## Details

Each manufacturer identifier maps to a named vector of PROSITE identifiers. The name for each PROSITE identifier is the IPI accession number where this PROSITE identifier is found.

If the PROSITE is a named NA, it means that the associated Entrez Gene id of this manufacturer identifier is found in an IPI entry of the IPI database, but there is no PROSITE identifier in the entry.

If the PROSITE is a non-named NA, it means that the associated Entrez Gene id of this manufacturer identifier is not found in any IPI entry of the IPI database.

Mappings were based on data provided by: Uniprot <http://www.UniProt.org/> With a date stamp from the source of: Thu Mar 7 17:01:43 2013

hugene20stprobesetREFSEQ is an R object that provides mappings between manufacturer identifiers and RefSeq identifiers.

## Details

Each manufacturer identifier is mapped to a named vector of RefSeq identifiers. The name represents the manufacturer identifier and the vector contains all RefSeq identifiers that can be mapped to that manufacturer identifier. The length of the vector may be one or greater, depending on how many RefSeq identifiers a given manufacturer identifier can be mapped to. An NA is reported for any manufacturer identifier that cannot be mapped to a RefSeq identifier at this time.

RefSeq identifiers differ in format according to the type of record the identifiers are for as shown below:

NG\XXXXX: RefSeq accessions for genomic region (nucleotide) records

NM\XXXXX: RefSeq accessions for mRNA records

NC\XXXXX: RefSeq accessions for chromosome records

NP\XXXXX: RefSeq accessions for protein records

XR\XXXXX: RefSeq accessions for model RNAs that are not associated with protein products

XM\XXXXX: RefSeq accessions for model mRNA records

XP\XXXXX: RefSeq accessions for model protein records

Where XXXXX is a sequence of integers.

NCBI <http://www.ncbi.nlm.nih.gov/RefSeq/> allows users to query the RefSeq database using RefSeq identifiers.

## Description

hugene20stprobesetSYMBOL is an R object that provides mappings between manufacturer identifiers and gene abbreviations.

## Details

Each manufacturer identifier is mapped to an abbreviation for the corresponding gene. An NA is reported if there is no known abbreviation for a given gene.

Symbols typically consist of 3 letters that define either a single gene (ABC) or multiple genes (ABC1, ABC2, ABC3). Gene symbols can be used as key words to query public databases such as Entrez Gene.

hugene20stprobesetUNIGENE is an R object that provides mappings between manufacturer identifiers and UniGene identifiers.

### Details

Each manufacturer identifier is mapped to a UniGene identifier. An NA is reported if the manufacturer identifier cannot be mapped to UniGene at this time.

A UniGene identifier represents a cluster of sequences of a gene. Using UniGene identifiers one can query the UniGene database for information about the sequences or the Entrez Gene database for information about the genes.

This object is a simple mapping of manufacturer identifiers to Uniprot Accessions.

Mappings were based on data provided by NCBI (link above) with an exception for fly, which required retrieving the data from ensembl <http://www.ensembl.org/biomart/martview/>

## Details

hugene20stprobeset\_dbconn returns a connection object to the package annotation DB. **IMPORTANT:** Don't call `dbDisconnect` on the connection object returned by `hugene20stprobeset_dbconn` or you will break all the `AnnDbObj` objects defined in this package!

hugene20stprobeset\_dbfile returns the path (character string) to the package annotation DB (this is an SQLite file).

hugene20stprobeset\_dbschema prints the schema definition of the package annotation DB.

hugene20stprobeset\_dbInfo prints other information about the package annotation DB.

## Value

hugene20stprobeset\_dbconn: a `DBIConnection` object representing an open connection to the package annotation DB.

hugene20stprobeset\_dbfile: a character string with the path to the package annotation DB.

hugene20stprobeset\_dbschema: none (invisible `NULL`).

hugene20stprobeset\_dbInfo: none (invisible `NULL`).
